

CopyCat Cinema 2020 RULES & GUIDELINES

Sponsored by the Kenworthy Performing Arts Centre, Idaho Central Credit Union, and PACT EMS

Please read and carefully consider the following guidelines for CopyCat Cinema 2020 contest. ALL ENTRANTS MUST ADHERE TO THE FOLLOWING RULES & GUIDELINES:

CopyCat Cinema 2020 is sponsored by the Kenworthy Performing Arts Centre, Idaho Central Credit Union, and PACT EMS. This year's contest will award over \$1500 in prizes. Entrants will re-create a two minute scene from the selected film (view the 2020 clip here: https://youtu.be/7_pR6mUYtOo) and must agree to the following rules and guidelines:

- All films must be made specifically for CopyCat Cinema 2020.
- Films may be completed and submitted by an individual, team, or family. If done by a group, please select a "Captain" as the team contact person.
- There is a limit of two (2) entries per person or household/group.
- Each film must use the movie clip referenced/provided and be no longer than 3 minutes (180 seconds). NO EXCEPTIONS. Opening and/or closing credits are not required, but (if added) may add up to an additional 20 seconds in total.
- This is a family-friendly event and the movie clip chosen has been selected for all audiences. Submissions containing language, vulgarity, or otherwise inappropriate content will be disqualified.
- All entries (including film clip and signed/completed waivers for each participant) must be submitted via email to operations@kenworthy.org by 11:59 PM January 17th. Submissions received after this date will not be included in the competition or the film festival screening. Included with your submission must be your NAME (or GROUP NAME), GROUP CAPTAIN/CONTACT NAME, EMAIL ADDRESS, and PHONE NUMBER.

PRIZES and JUDGING

Grand Prize (\$800), First Place (\$500), and Second Place (\$200) winners will be selected by the judges from the eligible participants. Submissions will be reviewed live by a panel of 6 judges from varying fields and professions during the live CopyCat Cinema Screening Event at 7:00 PM on January 23rd, 2020. Films will be prescreened for content during formatting. Films not complying with the Rules & Guidelines will be disqualified. Submissions will be judged on the interpretation of the selected movie scene, creativity, technical merit, and overall quality.

TO ENTER

Participants must email a digital file of their CopyCat Cinema submission and completed waivers/participant forms by 11:59 PM January 17th, 2020 to operations@kenworthy.org. Submissions created by more than one person, a group or a team are required to submit completed waivers/participant forms for each member. Children under 18 years old must have the permission of a Parent/Guardian to participate.

Each film may only be submitted once. Entrants may submit up to two (2) separate entries as per the Rules & Guidelines

1. In consideration of my participation in the production title (“Film”) as part of the CopyCat Cinema 2020 contest, I hereby consent to the photographing, recording, or reproduction in any other manner of my likeness, voice and activities, in whole or in part, including the use of video and audio recordings and web use (hereafter “recordings”). I hereby waive any right that I may have to inspect or approve the finished audio and/or video recordings that may be used in connection herein. I understand that I will receive no monetary compensation for my participation in this production, nor may I make any monetary claim in the future for this participation.

2. Filmmaker(s) and the CopyCat Cinema 2020 contest shall be the exclusive owner(s) of “Film” and “Recordings” giving them the right to, without limitation, in perpetuity throughout the universe, in any and all languages, in any and all media now known or hereafter invented: (a) exhibit, broadcast, use, reproduce and license others to use as they see fit all or any part of the Film and the Recordings; (b) edit, dub, subtract from, add to or modify the Recording and the Film in any manner, combine it with any other material and/or incorporate it into other films, projects or programs; and (c) use and license others to use my name, voice, likeness, image, photograph, performance, participation, expressions, personal experiences and biographical material (collectively “Name and Likeness”), in and in connection with the production, distribution, advertising, publicity, promotion, exhibition and other exploitation of the Recordings, the Film, and in connection with CopyCat Cinema 2020, Kenworthy Performing Centre, Idaho Central Credit Union, and PACT EMS products and services, an unlimited number of times, without any obligation of any kind to me whatsoever.

3. I represent that any music, images or other materials in the Recordings and the Film (and my furnishing of Pre-existing Materials, if any) are original or in the public domain and will not to the best of my knowledge (i.e., what I know or should know after the exercise of reasonable prudence) infringe upon the rights of any third party. I represent and warrant that I have all rights and authority to enter into this Waiver and Release (“Release”) and to grant the rights granted herein.

4. As used in this Release: (a) the term “Releasing Parties” means and refers to each of me, my heirs, next of kin, spouse, spousal equivalent, guardians, legal representatives, executors, administrators, successors and assigns; and (b) the term “Released Parties” means and refers to Filmmaker and the CopyCat Cinema 2020 contest and each and all of their respective parents, subsidiaries, related and affiliated companies, licensees, sponsors, successors and assigns, and the directors, officers, employees, agents, contractors, partners, shareholders, representatives and members of each of the foregoing entities.

5. I voluntarily assume any and all risks, known or unknown, associated with my participation in the CopyCat Cinema 2020 contest and actions and undertakings associated with my participation and the subsequent or simultaneous dissemination of the Recordings (collectively “my Participation”). I acknowledge that my Participation may present certain risks to me, and I hereby assume any and all risks associated therewith, including, without limitation, the risk of physical or mental or emotional injury, minor and/or severe bodily harm, and/or illness, which arise by any means.

6. I and the other Releasing Parties hereby voluntarily and knowingly, release, discharge and relinquish any and all claims, actions and lawsuits of any kind against the Released Parties related to or arising from my Participation, including, without limitation, travel to and from any location used in connection with the Film and Recordings, travel to and from the award ceremony, the making, taping, production, use, editing, distribution, licensing, and/or promoting of the Film and the Recordings and/or any portion thereof, including, without limitation, any claims, actions or lawsuits for wrongful death, negligence and/or other fault, either active or passive, personal injury, wrongful death, defamation, false light, violation of right of publicity, invasion of privacy, disclosure of embarrassing private facts, fraud, breach of contract, infringement of copyright, and negligent or intentional infliction of emotional distress.

7. I represent that I am at least 18 years of age, and that if I under 18 my parent or legal guardian has signed below.

8. I hereby agree not to assert any claim of any nature whatsoever against anyone relating to the exercise of the permissions granted hereunder.
